TOURNAMENT RULES (Failure To Read Is No Excuse!)

- The following rules plus the USBC rules will govern all participants in this tournament. Bowler must be a 2019-2020 USBC certified member.
- The "Anchor Lady Trio" consists of (2) males and (1) female, and the female must anchor the team. Bowlers will bowl (3) games on the same pair of lanes.
- Bowlers will use their highest 2018-19 book average of 21 games or more. If none, a bowler may use their highest 2019-20 Winter League average of (33) or more games as of March 27, 2020 (Verification must be brought at time of bowling). No summer league averages will be used. All others bowl scratch (230). No YABA averages will be accepted. THE 10 PIN RULE IS IN AFFECT.
- All bowlers will be required to initial averages on their first entry as submitted as correct prior to bowling the (2nd) game (it shall be the bowler's responsibility to verify his or her average). Failure to use proper averages, or to make corrections prior to bowling 2nd game, shall disqualify score and forfeit all monies if submitted average is lower than actual average, or base prize winning on submitted average if higher.
- Unlimited participation is allowed. A team with exactly the same partners may place only once in the prize list.
- Handicap will be 80% of 230 for men and 90% of 230 for women.
- Entry Fee is \$135.00; Prize Fund is \$90.00, Bowling / Expense is \$45.00.
- The prize fund is returned 100%: Team 95% and Individual 5%. The prize ratio will be 1 in 10. Individual awards are High Game and High Series for both scratch & handicap division. Under no circumstance will a bowler qualify for more than one award in the same category (Categories being Games or Series). Example: High Game Scratch and High Game Handicap.
- No entry will be accepted without entry fees. Checks will be accepted. Any NSF checks will forfeit entry (disqualify team), and there will be a NSF charge of \$32.00 on any returned check. **Make checks payable to: SOUTHERN IMPACT.**
- Send entry in early to get desired squad time (RECOMMENDED). Mail entries to: 2944 Lorraine Court, Marrero, LA 70072.
- Only a tournament officials can make scoring corrections without the bowler being disqualified. This also applies to any member of Southern Impact when bowling on the same pair of lanes, which needs corrections. Any errors in scoring must be made within 1 hour after the series has been bowled. **Automatic scores are the official scores. Any bowler who abuses the ball returns or scoring system will be disqualified.** In case of scores being lost through the computer, re-bowling will be permitted.
- In case of a tie for first place, co-champions will be declared. When ties occur, the prize money will be combined and divided equally among tied position winners. Payoff will be approximately 2 weeks after tournament closes, pending average verifications.
- All protests must be made to the tournament manager in writing (see USBC rule 329).
- Tournament manager or committee reserves the right to re-rate any bowler and accept or reject any or all entries and will decide all questions arising in the tournament. Their decisions will be final. Any protest or appeals must be in accordance with USBC rule 329.
- USBC Rule 319d is in affect. Failure to Report Prior Prize Winnings is cause for a forfeiture of entry fees and prize winnings. Any bowler who qualifies for total winnings of \$600.00 or more in the tournament must provide a tax identification number to receive awarded prize(s).
- Past PBA/PWBA/Senior PBA National Champions may be permitted to bowl, if their championship was not within the last 10 years. Past PWBA/PBA/Senior PBA/Amateur Regional Champions may be permitted to bowl, if their championship was not within the last 5 years. Former PBA/PWBA/Senior PBA members who have not held a card for the past year of the tournament start date are eligible to bowl. Current PBA/Senior PBA/Amateur members will be allowed to bowl if you have not won a Regional Championship in the last 5 years.
- Current PWBA/Amateur members will be allowed to bowl, if you have not won a PBA/PWBA Championship in the last 5 years.
- Only one PBA/PWBA member allowed per team.
- Premature termination of the tournament brought about by war, national emergency or causes relating thereto or there from; fires, strikes, lockouts, labor difficulties or other cause beyond the control of the ALT Tournament and All Star Lanes shall cause the foregoing prize schedule to be prorated in accordance with the number of entrants who have bowled, and there shall be no further liability.
